CORRIGENDUM

Sub: Two point combinations for steel traffic and composition of CONCORD rake.

Ref: Board's letter No. TCR/1078/2009/13 dt.10.11.09 (RC No.62 of 2009) and corrigendum thereto [Circulated vide CCM/ ECoR's Commercial Circular No.177(G)/09 dated 18.11.09 and corrigendum thereto].

- 1.0 In terms of Corrigendum No.18 to Rates Circular No.62 of 2009 [Circulated vide CCM/ ECoR's Commercial Circular No.40(G)/2011 dated 02.05.2011], loading of two point CONCORD rakes (for steel traffic only) in any combination of BRN/BOST/BFNS was permitted for any two point combinations within the same Zonal Railways for the period commencing from 30.04.2011 to 31.12.2011.
- 2.0 The matter has been reviewed. It has now been decided that the loading of two point CONCORD rakes (for steel traffic only) in any combination of BRN/BOST/BFNS may be permitted for any two point combinations within the same Zonal Railways for the period beyond 31.12.2011 and upto 30.06.2012.
- 3.0 All other details of the Rates Circular under reference will continue to apply unchanged.
- 4.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.
