**Sub:-** Modification in some of the prescribed conditions in tender scheme of VPs to generate maximum revenue

**Ref:-** Railway Board letter No. 2012/TC(FM)/11/25 dt. 7.12.2012

Railway Board vide their above referred letter dt. 7.12.2012 has informed that in a vigilance case some irregularity was detected in allotment of tender of VPs. As per para No. 22.0 of FM Circular No. 2 of 2007 issues vide letter No. 2007/TC(FM)/10/3 dt. 20.2.2007 which states that power to modify the conditions of scheme:- Zonal Railways, with the personal approval of General Managers, may modify some of the conditions, prescribed in the scheme which are in the spirit of maximization of revenue. Conditions having financial implications may only be changed with the concurrence of FA&CAOs".

In this case some insertions was made after negotiation and incorporated in tender awarding letter.

The case has been investigated by Board Vigilance and observed that the condition laid down by Railway Board for modifying the conditions prescribed in the scheme were not followed.

The case was referred to CVC who has observed as under:

"The condition was recommended by tender committee and accepted by the TAA after negotiation and incorporated in tender awarding letter. At this stage General Manager did not have any power to modify the tender conditions. The commission would, therefore, advise the General Manager / Zonal Railway may modify some conditions prescribed in the scheme which are in the spirit of maximization of revenue before publication of tender condition, suitably, by way of system improvement."

Divisions are advised to ensure strict compliance of the above stated matter.
