## Commercial Circular No.14(G)/2013

Sub: Unloading of export cargo arriving by Indian Railway general service wagons at rail terminals of Container Train Operators.

In continuation to Railway Board letters under reference above, the issue of unloading export cargo, arriving in Indian Railways general service wagons at rail terminals of Container Train Operators having Customs bonded warehouse (ICD/CFS), without being converted to PFT, has been examined and permitted by Railway Board subject to following:

1. All export traffic booked in Indian Railway general service wagons shall be consigned as inward traffic at the terminal of the Container Train Operator.
2. Rail terminals to which such export cargo is booked shall have Customs bonded Warehouse.
3. The terminals will handle cargo booked in IR general service wagons meant for export only. In no case domestic traffic booked in IR general service wagons shall be handled at the terminal.
4. Traffic carried in Indian Railway general service wagons will be charged at Normal Tariff rates applicable for movement by Railway wagons.
5. Booking and delivery of cargo will be done by the commercial staff of the Railways.
6. No outward booking of traffic in Indian Railway general service wagons is permitted in these terminals.
7. This permission is purely temporary and subject to review.

This is issued with the approval of Traffic Commercial (FM) Directorate.
