- Sub: Merging of (1) MNDH, (2) LAE, (3) MIMH, (4) LBPM & (5) FCMH stations/sidings from SBP Division, East Coast Railway to Raipur Division, South East Central Railway.

Instructions issued vide CCM/SEC Railway's Letter No. C/SECR/BSP/Sdg/MIEL/MNDH/654 dt. 24.01.2013 (Rates Circular No. 09 (G)/2013) is reproduced below:-

"It is hereby notified for general information that keeping in view the operational requirements in the wake of coming up of Naya Raipur and New Kendri section and a new Railway line between these two stations. Central Government has decided to revise the jurisdiction of Raipur division of South East Central Railway with Sambalpur Division of East Coast Railway.

The following stations/siding of Sambalpur Division of East Coast Railway have been merged with Raipur Division of South East Central Railway and revised numerical codes are as given below:-
