Sub: Haulage Charge for movement of fruits and vegetables traffic in containers.

- 2) Board's letter No.2007/TC-I/302/1 Pt.H dt.16.11.2012 (Rates Circular No.34 of 2012) {CCM/ECOR's Commercial Circular No.117 (G)/12 dtd.19.11.2012}

It has been decided by Railway Board to allow 25% concession in the Haulage Rate circulated vide Rates Circular No.34 of 2012 (and as amended from time to time) for movement of fruits and vegetables in containers.


The concession will be applicable on production of letter of sponsorship from Ministry of Agriculture and/or its National Horticulture Board in original alongwith the forwarding note by container train operator (CTO).A false declaration by CTO would attract penalties as per the extant rules (refer Rule No.126 of Goods Tariff).

These instructions will be effective from 15.03.2013 and remain valid upto 14.03.2014.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.

All concerned to note and act accordingly.
