Sub: AUTOMOBILE FREIGHT TRAIN OPERATOR (AFTO) SCHEME.

Ref: Freight Marketing Circular No.2 of 2013 issued vide Board's letter No.2010/TC(FM)/25/4 dated 22.02.2013 {CCM/ECOR's Commercial Circular No.20 (G)/2013 dtd.26.02.2013}

- 1.0 Policy on "AUTOMOBILE FREIGHT TRAIN OPERATOR (AFTO) SCHEME" has been issued to all concerned vide above referred Circular/letter.
- 2.0 The following changes are made to the AFTO policy issued vide Freight Marketing Circular No.2 of 2013 dated 22.02.2013 {CCM/ECOR's Commercial Circular No.20 (G)/2013 dtd.26.02.2013}:
 - (i) 2nd para at page 1 of Board's aforementioned Freight Marketing Circular may be replaced as "AUTOMOBILE FREIGHT TRAIN OPERATOR (AFTO) SCHEME" issued vide FM Circular No.18 of 2010 dated 19.07.2010 {CCM/ECOR's Commercial Circular No.111(G)/2010 dtd.21.07.2010}, stands superceded by this Scheme. This issues with the concurrence of Finance Directorate of Ministry of Railways.
 - (ii) The word "para 12.1" referred in the last line of para 16.2 of aforesaid policy may be read as "para 16.1".
