Sub: Installation of electronic in-motion weighbridges (EIMWBs) at railway owned goods sheds by private party.

Ref: Board's letter No.TC-I/2005/108/3 dt.06.08.2012 (Corrigendum to Rates Circular No.12 of 2007), Circulated vide CCM/ECOR's Commercial Circular No.79(G)/2012 dated 08.08.2012.

Guidelines for installation of electronic in-motion weighbridge(EIMWB) of private siding on railway land are stipulated vide Board's letter under reference (Circulated vide CCM/ECOR's Commercial Circular No.79(G)/2012 dated 08.08.2012).


Clarification has been sought regarding applicability of the afore-mentioned guidelines in the case of railway owned goods sheds.


