Commercial Circular No.68(G)/2013

Dt.03.06.2013

Sub: Classification of Iron Ore.

- 1.0 In partial modification of Rates Circular No.36 of 2009 and Addendum thereto {CCM/ECOR's Commercial Circular No.85(G)/09 and corrigendum thereto), sanction of the Central Government is hereby accorded for furnishing the Monthly Excise Return of the month prior to the previous month if indent is registered during the first 15 days of the month.
- 2.0 Accordingly, Sub Para 3 (B) I (b) of Rates Circular No.36 of 2009 may be read as under:
 - (b) At the time of registration of each indent, consignor will furnish certified copies of all the documents mentioned in Para 3 (A) I as well as a copy of the Monthly Excise Return **for the month prior to the previous of the current month** for each rake if indent is registered during the first 15 days of the month or a copy of the Monthly Excise Return **for the month prior to the current month** for each rake if indent is registered after 15th of the month (say if indent is registered on any date between May 1 to May 15, 2013 then Monthly Excise Return of March 2013 and if indent is registered on any date between May 16 to May 31, 2013 then Monthly Excise return of April,2013 will have to be furnished). These documents should be submitted by the consignor on behalf the consignee".
- 3.0 All other terms and conditions stipulated in Rates Circular No.36 of 2009 will continue to apply unchanged.
- 4.0 These instructions will come into force with effect from 10.06.2013.
- 5.0 This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
