## **CORRIGENDUM**

**Sub: Policy Guidelines-Transportation Products-For Sugar and Chemical Manures Traffic.**

**Ref: Board's letter No.TCR/1078/2009/13 dated 10.11.2009 (RC No.62 of 2009) and Corrigenda thereto {CCM/ECOR's Commercial Circular No.177(G)/09 dt. 18.11.2009 and corrigendum thereto}.**

1. In terms of Corrigendum No.37 to Rates Circular No.62 of 2009, guidelines regarding Transportation Products were issued for arresting the shift of Cement traffic from Rail to Road.
2. The matter has been reviewed and it has been decided to extend the facility to permit all the combination of two point rakes for covered wagons at Trainload class rates to Sugar and Chemical Manures on the same terms and conditions as listed in Para 1.2 of Corrigendum No.37 to Rates Circular No.62 of 2009 {CCM/ECOR's Commercial Circular No.177(G)/09 dt. 18.11.2009}.
3. These instructions will come into force w.e.f. **13.08.2013** and will remain valid till **30.09.2013**.
4. A monthly appreciation report should also be furnished by Zonal Railway.
5. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.




