INTRODUCTION

1. Address of Shri M. Akhtar, CPO/ECOR:-

Shri M. Akhtar, CPO/ECOR/BBS welcomed the General Secretary/ECORSU, Shri N. Satpathy, President/ECORSU, Smt. D.Shaleel, Working President/ECORSU, Central Office bearers of ECORSU, GM/ECOR, all PHODs/CHODs and his colleague Officers to attend the 27th ZPNM Meeting of East Coast Railway. He told that today (22-08-2013) a unique one-day PNM meeting is being held where there is no agenda item from the Union side and therefore, he requested HODs of other departments to place agenda items, if any. But unfortunately, no one placed any agenda item. At last CPO asked the General Secy./ECORSU that why they are opposing merger of the MCS cadre with the HQ Cadre of Personnel Department. The Union replied that after merging it will affect the staff seniority. But CPO & CPO(Admn.) said that there are less number of staff working in MCS Workshop i.e. approximately 14 staff, therefore, it will not affect the seniority. CPO was greatly dissatisfied with the performance of KUR Division due to large number of pending compassionate ground cases (27), MACP cases (187) etc. Shri P.Nayak from Union side requested to appoint one APO for Stores Department which is a centralized cadre in which around 400 staff are working and it is a zonal controlled Department. Then, CPO requested the Genl. Secy and President/ECORSU to address the House.

2. Address of Shri N.Satpathy, President/ECORSU:-

Shri N.Satpathy, President/ECORSU requested the General Secy./ECORSU to welcome the GM/ECOR to attend the farewell meeting with a flower bouquet. He appreciated the commendable work of the GM/ECOR like holding the weekly staff grievance meeting for the first time by making a Grievance Cell through which the Railwaymen's genuine grievances have been mitigated within a short period for which they and their family members remain grateful to the GM. Despite of the financial difficulties and shortage of funds, the GM has achieved success for which East Coast Railway climbed the ladder to reach the No.1 position in loading in Indian Railways within a targeted time. He has also achieved many such milestones in allied areas which was not possible by the earlier GMs and due to this progressive work of the GM, staff of ECORly will remember him and his achievements. Then, he requested Shri Ch. Gandhi, Genl. Secy/ECORSU to address the house.

3. Address of Shri Ch. Gandhi, Genl. Secy/ECORSU:-

Shri Ch. Gandhi, Genl. Secy/ECORSU started his speech by greeting the respected GM, CPO, CPO (Admn.), all PHODs, CHODs, other Officers, President/ECORSU, Working President/ECORSU and other delegates from the Union.

He told that this is only a farewell meeting and just reviewed the remarkable achievements of GM for ECoRly and visible improvements in most of the fields during his tenure, the Union will not place the agenda items. He told this GM has done so many remarkable things like developing infrastructure facilities in TLHR, BCHL, PRDP, finalizing long pending compassionate ground appointment cases, instead of shortage of funds cleared the OT arrears, construction of Rly. quarters, tie-up with corporate hospitals, improvement of Sevanagar Colony, sports & games activities at Hqrs. and Divisions, filling of large no. of vacancies especially in Gr. 'D' post, Inter-Railway Transfer, change of category, peaceful conduct of the secret ballot elections, etc. He greatly appreciated the style/way of working of the GM and wishes a happy and healthy retirement life.

4. Address of Shri Indra Ghosh, General Manager/ECoR:-

Shri Indra Ghosh, GM/ECoR thanked all who assembled in the meeting for cooperating him and appreciated his way of working for Railway. He expressed his past experiences and achievements in ECoRly. and advised the Union to come with only genuine cases in the PNM and try to change the conception about the Union.
