Commercial Circular No. 95(G)/2013

Sub: Charges for the transport of consignments by Special Trains.

Ref: Board's letter No.TCR/2206/96/1 dated 11.09.2002 (Rate Instructions No.56 of 2002), dated 09.03.2006 (Rates Circular No.19 of 2006) and dated 11.12.2008 (Rate Circular No.71 of 2008) circulated vide CCM/ECOR's Commercial Circular No.43(G)/2206 dated 20.03.2006 & 186(G)/2008 dated 19.12.2008 respectively.


1. It has been decided that the charges for transport of consignment by special trains notified vide Board's letter cited above may be revised as under with effect **from 30.08.2013**.

For BG/MG/NG Rs.3720/- per KM subject to the minimum charge of Rs.372000/-.

2. If the charges calculated at the tariff classification work out higher than the charges at the rate of Rs.3720/- per km, the former will be leviable.
3. No other charge will be leviable in addition.
4. There will be no change in the other conditions notified in Board's letter No.TCR/1246/72 dated 27.12.1973.
5. The levy of empty haulage charge in respect of privately owned well wagons shall be done in terms of Para 2(6) of Board's letter No.TCR/1246/72 dated 27.12.1973. However, the levy of empty haulage charges in respect railways owned well wagons shall be done in terms of Board's letter No.TCR/1264/72 dated 20.07.1982 as modified vide Para 2 of Board's letter No.TCR/1264/72 Pt. dated 13.09.1983. The validity of instructions dated 13.09.1983 has been extended indefinitely as per wireless message No.TCR/1264/95/1 dated 17.10.1995
6. This issues with the concurrence of the Finance Directorate in the Ministry of Railways.

All concerned to note and act accordingly.
