Sub: Dynamic Pricing Policy – Levy of Busy Season Charge.  
Ref: Board's letter No.TCR/1078/2008/11 dated 25.03.2013 (Rates Circular No. 12 of 2013 [Circulated vide CCM/ECOR's Commercial Circular No.35(G)/2013 dtd. 26.03.2013].

1. In supersession of Board's Rates Circular No.12 of 2013, sanction of the Central Government is hereby accorded to levy of Busy Season Charge at the rates mentioned in the table below during the Busy Season:

S.No.	Commodities	Rates
1	All Commodities	15%
2	Container Traffic	Nil
3	Automobile Traffic moved in NMG, BCACM,BCCNR & BCACBM wagons	Nil


2. The following periods of the Financial Year have been notified as Busy Season and Lean Season:

**Busy Season: 1<sup>st</sup> April to 30<sup>th</sup> June  
1<sup>st</sup> October to 31<sup>st</sup> March**

**Lean Season: 1<sup>st</sup> July to 30<sup>th</sup> September**

3. All other conditions regarding levy of Busy Season Surcharge as stipulated in Rates Circular No.38 of 2011 will continue to apply unchanged {CCM/ECOR's Commercial Circular No.119(G)/2011 dated 13.10.2011}.
4. These instructions will come into effect from **01.10.2013** and will remain in force till further advice.
5. This issues with the concurrence of Finance Directorate of Ministry of Railways.


