**Sub: List of combination of two point destination terminals for covered wagons.**



1. In terms of Annexure-IV to Rates Circular No.62 of 2009 amended from time to time, a list of combination of two point destination terminals for covered wagons was notified.
2. The matter has been reviewed. It has now been decided that the two point combination of "Saharanpur (SRE) + Partapur (PRTP)" may be included in the list of two point combination of Northern Railway.
3. All other details of the Rates Circular under reference will continue to apply unchanged.
4. These instructions will come into force w.e.f. **05.09.2013**.
5. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.




