**Sub: Exemption from mandatory (100%) weighment in case of containerized Import traffic.**

**Ref: Board's letter No.TC-I/2006/109/6pt.3 dated 17.06.2013 [(Rates Circular No. 16 of 2013)( Circulated vide CCM/ECOR's Commercial Circular No.75(G)/2013 dtd.18.06.2013)].**

Please refer to Rates Circular No. 16 of 2013 vide which dispensation from weighment in the case of containerized Import traffic has been permitted on an experimental basis for a period of Six months w.e.f 24.06.2013 subject to fulfillment of the conditions laid down therein.

The matter has been reviewed and it has been decided to extend the validity of instructions regarding dispensation from weighment in the case of containerized Import traffic upto 23.03.2014.


Northern Railway and Central Railway will conduct random weighment checks of containerized Import traffic for a representative period of 15 to 20 days and furnish their reports by 28<sup>th</sup> February,2014, positively.

FOIS will submit its report on item Nos. (a) to (c) of Rates Circular No. 16 of 2013, by 28<sup>th</sup> February 2014 , positively.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.


