Sub: Amendment No.2 to Revised Private Freight Terminal (PFT) Scheme.

Ref: Railway Board's Freight Marketing Circular No.05 of 2012 dated 23.04.2012.
{CCM/ECOR's Commercial Circular No.37(G)/2012 date.25.04.2012}

1.0 Please refer to Freight Marketing Circular No.05 of 2012 issued vide Board's letter No.2011/TC(FM)/14/14 dated.23.04.2012{CCM/ECOR's Commercial Circular No.37(G)/2012 date.25.04.2012} wherein Revised Private Freight Terminal (PFT) Scheme was issued.

2.0 It has been decided to make following amendments in the aforesaid policy:-

2.1 **Para 20.3 of the Circular may be read as under:-**


Para 20.3- Revenue sharing to be paid to RA will be ₹16/- per ton. The sharing of revenue shall be for the tonnage handled as ascertained from Railway receipt.

2.2 The above changes in the policy will come into force with immediate effect.


