## Commercial Circular No. 07(G) / 2014

Sub: Opening of Private siding of M/s. Jindal Steel and Power Limited (JSPK). Kerejanga.

1. It is hereby notified that the Private siding of M/s. Jindal Steel and Power Limited (Alpha Code: JSPK & Numerical Code: 12221474 ) served by Kerejanga station over SBP Division is temporarily opened as a full rake handling point for the following commodities:

> Inward: Iron Ore Fines, Iron Ore lumps, Imported Coking Coal, Non-Coking Coal, Non- Coking Coal for coal washery, Dolomite & Dolomite fines, Lime Stone & Lime Stone fines, Quartzite, Misc. Flux & Ferro Alloy, Cement & MS Slab.

Outward: Steel & Slag.

- 2. The chargeable distance for the traffic booked from/to the siding will be reckoned as Kerejenga (KPJG) + 5.80 Km
- 3. In case, any additional shunting operation is performed by Railway Locomotive inside the siding, necessary shunting charges will be levied as per extant rules.
- 4. Guard of the train will enter placement & release time of rakes in the register to be maintained in the Freight office for calculation of Demurrage charges and also submit number of hours of Railway Loco utilized for any additional shunting operation inside the siding, if any, for levy of necessary shunting charges.
- 5. This notification shall remain valid up to 31/03/2015.
