Out which an amount of Rs 4610/- has already been submitted by you towards EMD along with your offer vide i. TDR No.0498600, Dtd.13.05.2010 for Rs.4000/-, ii.DD No. 133089, dated 28.12.2015 for Rs.610/- issued by SBI/SBP. The balance amount of security deposit i.e. Rs 6418/- will be recovered by percentage deduction originally @ 10% from the periodic payments to be made you on account of work done, till the balance amount of security is recovered.

In addition to above, a per extant rule, you have to submit 5% of the accepted value i.e Rs.11028/- towards performance guarantee (PG) normally within 30 days of issue of acceptance letter i.e. up to 18.02.2016 before signing the agreement and the same should be valid upto 60 (sixty) days of expiry of the contract period / maintenance period (if any extension of time for submission of PG beyond 30 days and upto 60 days from the date of issue of LOA i.e. upto 19.03.2016 may be given by the authority who is competent to sign the contract agreement. However, a penal interest of 15 % per annum shall be charged for the delay beyond 30 days i.e. from 31<sup>st</sup> day after the date of issue of LOA. In case you fail to submit the requisite PG even after 60 days from the date of issue of LOA i.e. upto 19.03.16 the contract shall be terminated duly forfeiting the full amount of EMD and other dues, if payable against this contract and you shall be debarred from participating in re-tender for this contract.
