
7. **Period of contract** : 03 years from the date of commencement.
8. **The work shall be executed as per the Special Terms and Conditions of Contract mentioned in Annexures A1 to A3 of the tender document.**
9. **Terms of Payment** : The monthly bills are to be submitted to SSE(C&W)/Coaching/Visakhapatnam. Payment shall be made monthly by Sr. Divisional Finance Manager, East Coast Railway, Waltair. Sr. Coaching Depot Officer is the bill passing authority.
10. Payment shall be made based on the average passenger satisfaction index (PSI) as mentioned in Clause 9 of Annexure A1 of the tender document. The payment shall be made after the statutory deductions as mentioned in Clause 20 of GCC of the tender document and penalties as mentioned in Clause 10 of Annexure A1 of the tender document.
11. **Adherence to Statutory Requirements** : You shall be responsible for the adherence all the statutory labour requirements as mentioned in the tender document.
12. **Conditions of Contract** : The contract will be governed by General Conditions of the contract alongwith special terms and conditions laid down in the tender documents and **accepted by you without any deviations.**
