Your offer against the quotation in connection with the above work has been accepted by the Railway administration at rates, terms condition shown in the enclosed scheduled of rates and offer particulars mentioned hereunder-

The rate accepted is inclusive of all lead, lift, Sale tax and other charges leviable by government from time to time.

Until a formal agreement is prepared and executed, acceptance of your offer at the accepted rates shown in the enclosed schedule of rates and condition shall constitute a binding contract subject to modifications, if any, that may be mutually agreed upon and indicated in this letter the tender documents assigned and submitted by you along with your offer shall form part and parcel of the contract.

The agreement in question is being drawn in the office which should be signed by you within 30(thirty) days of receipt of this letter, failing which necessary action as per clause provided in the S.E.Railway schedule of labour material rates Vol-I(1992 Revised Edition) with C.S. up to date shall be taken against you.

The value of contract at the accepted rates shown in the enclosed schedule work out Rs 491550/- ( Four lakh ninety one thousand five hundred fifty only) **for 02 years** .

(For Veg. Diet Rs.2,26,610/-, Non. Veg. Diet Rs.2,26,610/-, For Veg. Diabetic diet .Rs.22630/- For Non-Veg Diabetic diet **Rs.15300/-** & For Milk & Bread diet Rs. 400/-) ( Rupees **Four** lakh ninety one thousand five hundred fifty only ) for Two Years.

You are required to commence the work on or before **Dt.14.03.2016** and the period of Contract is valid for 02 (Two) years from the date of commencement.

You should start the work from **14.03.2016** positively. The entire work should be completed in all respects within 02 years i.e.**14.03.2016 to 13.03.2018**.



The total security deposit payable by you work out to Rs.24578/- (Rupees Twenty four thousand five hundred seventy eight only), which will be deposited as initial security before signing of Agreement document and execution of the work in the following form of in favour of FA & CAO, East Coast Railway, Chandrasekharpur, Bhubaneswar. Since you have deposited an amount of Rs.16340/- through Banker's Cheque bearing no. 586505 dt. 03.02.16 issued by Bank of Baroda, GM college Road is retained towards initial security deposit and the difference between the total security and the initial security deposit will be recovered by a percentage deduction originally 10 % from the periodic payment to made to you on the account of the work done.

Please furnish a Performance Guarantee in the form of an irrevocable bank guarantee amounting 5% of the contract value i.e. Rs 24578/- (Rupees Twenty four thousand five hundred seventy eight only ) drawn in favour of FA&CAO/East Coast Rly. Bhubaneswar, within thirty days and up to sixty (60) days from the date of issue LOA may be given by the authority who is competent to sign the contract agreement. However a panel interest of 15% per annum shall be charged for the delay beyond thirty (30) days i.e. from 31<sup>st</sup> day after the date of issue of LOA. In case the contractor fails to submit the requisite PG. even after sixty days from the date of issue of LOA, the contractor shall be terminated dully forfeiting EMD and other dues, if any payable against the contract. The fail contractor shall be debarred from participating in retender for the work

On completion of the work, certified by Sr. DMO/ECOR/SBP and Chief Matron, Sambalpur and on production of "NO CLAIM" certificate by the successful bidder, the full amount of security deposit will be refunded.
