- a]. You are advised to **Start the contract work within 15 days** from the date of issue of this letter.
- b]. The SD (Security Deposit) for the above work @ 5% of the accepted contract value i.e. of Rs.14,32,260/- is Rs.71,613/- (Rupees Seventy one Thousand Six hundred Thirteen) Only. You have deposited Rs. 28,650/- as EMD vide DD No.944241 Dated.05.05.2015 of PNB/Jatni. Balance amount of SD i.e. Rs.42,963/- (Forty Two Thousand Nine Hundred Sixty Three) Only have to be deposited before commencement of Work through DD. No deduction towards security deposit to be made from running bills.
- c]. The performance Guarantee (PG) for the above work @ 5% of the accepted contract value i.e. of Rs.14,32,260/- is Rs.71,613/- (Rupees Seventy one Thousand Six hundred Thirteen Only). you have to deposit as Performance Guarantee (PG) before executing an Agreement, in following forms :
 (i) A deposit of Cash (ii) Irrevocable Bank Guarantee. (iii) Government Securities including State Loan Bonds at 5% below the market value. (iv) Deposit Receipts, Pay Orders, Demand Drafts and Guarantee Bonds. These forms of Performance Guarantee could be either of the State Bank of India or of any of the Nationalized Banks. (v) Guarantee Bonds executed or Deposits Receipts tendered by all Scheduled Banks. (vi) A Deposit in the Post Office Saving Bank. (vii) A Deposit in the National Savings Certificates. (viii) Twelve years National Defence Certificates. (ix) Ten years Defence Deposits. (x) National Defence Bonds and (xi) Unit Trust Certificates at 5% below market value or at the face value whichever is less. & Also, FDR in favour of FA & CAO, East Coast Railway, Bhubaneswar (free from any encumbrance) may be accepted.
 This P.G. will be initially valid up to the stipulated date of completion plus 60 days beyond that, in case, the time for completion of work gets extended, the contractor shall get the validity of P.G. extended to cover such extended time for **completion of work plus 60 days.**
- d]. You are requested to deposit the above Performance Guarantee (PG) amount and execute an 'Agreement' for the above work within 30 days from the date of issue of this Letter Of Acceptance (LOA), failing which a penal interest of 15% per annum shall be charged for the delay beyond 30 (thirty) days, i.e. from 31st day after the date of issue of LOA. In case you fail to submit the requisite PG even after 60 days from the date of issue of LOA, the contract shall be terminated duly forfeiting EMD and other dues, if any payable against this contract and you will be debarred from participating in re-tender for this work.
 Further it is clarified that. In case of non submission of PG within 30 days by you, 07 days notice will be served. If you fail to submit P.G. within 15 days from the date of issue of 07 days Notice, 48 hours Notice will be served to you and contract will be terminated, if there will be no positive response from the contractor. In any case, this can not be stretched beyond 60 days from the date of issue of LOA.
- e]. You will have to fulfill all the special conditions as stipulated in the original Tender document. No Railway Accommodation will be provided to you by the Railways and you will have to make your own arrangement for accommodation of your Tractor, Trailer, Labour, and Stores etc.
- f]. A Fine of Rs. 200/- (Rupees Two Hundred Only) will be charged for failure of Lifting & Disposal of each 100 Cft. Of Garbage and is to be recovered from running bills or security deposit.
- g]. The Driver, Labour, with his Tractor Trailer should report CHI/HI, E.Co.Railway/PURI at 6 a.m. daily at his office premises to take up the conservancy work as directed by him or any authorized medical authority.
- h]. You will have to submit the Certificate of the Vehicle and its carrying capacity, which is to be used for this purpose before executing the work, at office of the CHI/HI / ECoR./PURI.
