Pursuant to acceptance of 7th Central Pay Commission recommendations for abolition of **Dual Charge Allowance (DCA)** in Chapter 8.3 of their report and covering the same under a new Additional Post Allowance by "Committee on Allowances", DCA has ceased to exist with effect from 01.07.2017 and has been replaced by APA.

2. Formulation of revised guidelines/instructions for Additional Post Allowance (APA) is under active consideration with Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training).

3. It has come to the notice of this Ministry that dual charge arrangement is still being resorted in some Zonal Railways after 01.07.2017. It is, therefore, directed that the practice of dual charge arrangement shall not be resorted to on Zonal Railways. Guidelines pertaining to APA as and when finalized will be circulated for information and compliance.
