Attention is invited to this Ministry's letter of even number dated 21.09.2015 (RBE No.110/2015) laying down guidelines for filling up of posts against Scouts and Guide quota on the Railways.

2. The eligibility criteria for assessment of candidates applying against Scouts and Guide Quota vacancies have been reviewed and it has been decided to amend para 8 of Board's instructions ibid as under:

(A)	Written Test	60 Marks
	The written test will consist of 40 objective questions (40 marks) & 1 essay type question (20 marks) relating to Scouts and Guides Organization and its activities and General knowledge for Grade Pay ₹1900/- and Grade Pay ₹1800/-. The syllabus for this will be as per Annexure-II.	
(B)	Marks on certificates	40 Marks
	(i) Participation/ Service rendered in National Events/ National Jamboree (including All Indian Railway Events):	10 Marks
	• First Two certificates (i.e. minimum eligibility qualification)	Nil
	• One additional event	07 Marks
	• Two or more additional events	10 Marks
	(ii) Participation / Service rendered in State Events/Rallies:	10 Marks
	• First Two certificates (i.e. minimum eligibility qualification)	Nil
	• One additional event	07 marks
	• Two or more additional events	10 Marks
	(iii) Specialized Scout/Guides course organized at National/ State/All Indian Railways level:	10 Marks
	• One Course	07 marks
	• Two or more Courses	10 Marks
	(iv) Participation in District Rallies:	10 marks
	• One certificate	Nil
	• Two certificates	07 Marks
	• Three certificates	10 Marks
	TOTAL	100 MARKS
