

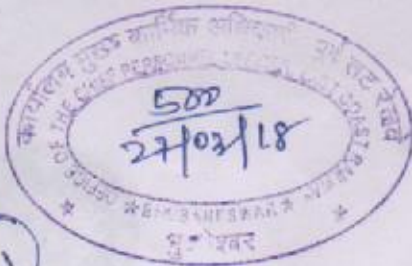

Sub:- Policy letter on cashless treatment scheme in emergency (CTSE) in empanelled hospitals for retired employees and their dependent family members.

Ref:- Board's letter of even no. dt. 24.01.2017 & 20.02.2017.

In partial modification of Board's above cited letter dt. 24.01.2017 Ministry of Railways with the approval of the competent authority had decided to do away with the condition of depositing advance amount by a CTSE member in Private empanelled Hospitals at time of admission. Further to this it has also been decided that bill generated for the period up to which the emergency is not established or 48 hours (whichever is earlier) will be borne by the Zonal Railways.

In case emergency is not established then reimbursement made by railways shall not be construed as automatic referral for the purpose of undertaking further treatment in the said private hospital.

Other terms and conditions issued from time to time will remain the same.

This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
