Sub: First Aid training to be made mandatory for all running and station staff at the time of joining and every three years thereafter.

In compliance to the Order of Hon'ble Supreme Court, an expert committee was constituted by AIIMS, New Delhi to examine the issue of providing the emergency medical facility in trains. The report has been received and with regard to training it has been recommended that :-

- "Training pertaining to first aid to be made mandatory for all running and station staff at the time joining. The same to be renewed periodically in every 3 years."
2. With regard to above it is stated that in Railways training pertaining to first aid is already mandatory as a part of training being given at the time of induction in services.
 3. All Zonal Railways/PUs etc. may please ensure that all running staff and station staff are given first aid training at the time of joining and to repeat the same every three years.
