





1. In terms of Board's letter No. 2013/E(GR)II/1/5 dated 20.05.2014, the validity of the scheme of engagement of Private Medical Practitioners as Contract Medical Practitioners was extended for a period of three (03) years w.e.f. 13.01.2015 i.e., upto 12.01.2018. Further, in terms of Board's letter No. 2013/E(GR)II/1/5 dated 07.09.2015, the validity of the scheme of engagement of Retired Railway/Government Doctors as Contract Medical Practitioners was extended for a period of three years from 16.07.2015, i.e. upto 15.07.2018.

2. The matter regarding extension of validity of the scheme of engagement of Private Medical Practitioners/Retired Railway or Government Doctors as CMPs was under consideration in this Ministry and it has been decided with the approval of the Board that the validity of both these schemes of engagement of Private Medical Practitioners as CMPs and Retired Railway/Government Doctors as CMPs, **are extended until further orders.**

3. This issues with the concurrence of Finance Directorate of the Ministry of Railways.





3. This issues with the approval of Finance Directorate of the Ministry of Railways.


