**Sub:-** Educational qualifications for recruitment/promotion of Post Graduate Teachers- Computer Science.

**Ref:-** Board's letter of even no. dated 22.02.2016.

The minimum qualifications for recruitment/promotion of Post Graduate Teachers working in Railway Schools have been laid down in Board's letter of even No. dated 22.06.2016. However, in the said letter minimum recruitment qualification for the post of Computer Science Teacher (TGT/PGTs) has not been prescribed. This issue was under consideration for some time.

2. It has now been decided that henceforth the essential minimum qualifications for recruitment/promotion of TGTs/PGTs (Computer Science) in Railway Schools will be as under:


TGT(Computer Science)	<p><b>Essential:</b></p> <p>At least 50% marks in aggregate in any of the following:</p> <ol style="list-style-type: none"><li>1. Bachelors Degree in Computer Application (BCA) from a recognized university.</li></ol> <p><b>OR</b></p> <p>Graduation in Computer Science from a recognized university. (provided that the computer science subject must be studied in all years as main subject)</p> <p><b>OR</b></p> <p>BE/B.Tech (Computer Science/information Technology) from a recognized university</p> <p><b>OR</b></p> <p>Graduation in any subject and 'A' level course from DOEACC, Ministry of Information &amp; Communication and Technology, Govt. Of India.</p> <p><b>Note:</b> Qualifications are relaxable at the discretion of the competent authority for reasons to be recorded in writing, in the case of candidates otherwise well qualified.</p>

<p>PGT(Computer Science)</p>	<p><b>Essential:</b></p> <p>At least 50% marks in aggregate in any of the following:</p> <p>(i) B.E or B.Tech (Computer Science/IT) plus Post Graduate Diploma in Computer Applications or B or C Level Diploma from Doecac, Ministry of Communication and IT plus One Year Teaching Experience.</p> <p><b>Or</b></p> <p>(ii) M.Sc.(Computer science)/MCA plus One Year Teaching Experience.</p> <p><b>Or</b></p> <p>(iii) Master of Engineering or M.Tech (Computer Science/IT).</p> <p><b>Note:</b> For subsequent Promotion, the incumbent will have to acquire B.Ed or equivalent.</p>


