Sub: Charges for providing Brakevans in Wagon Investment Scheme (WIS) rakes.

Please refer to Board's letter No.2007/TC(FM)/4/3 dated 01.01.2013 {CCM/ECOR's Commercial Circular No. 10(G)/13 dtd.25.01.2013} with regard to interim orders of Board for levying of 0.5% additional charges on Normal Tariff Rates (undiscounted freight) as payment for attaching Railway's Brakevan to WIS rakes. These orders were communicated vide above commercial circulars under reference. These instructions were valid up to 31.12.2014.

Approval of Ministry of Railways (Railway Board) is hereby accorded for further continuance of the above orders upto 31.12.2015 or the date when the WIS Customer procures the Brakevan and it is actually inducted, whichever is earlier.

The matter may be taken up with WIS customers who have not procured Brakevans so far to expedite procurement of Brakevans within the stipulated target date of 31.12.2015


