**Commercial Circular No.28(G)/2015**

Date: 16.03.2015

Sub: Rates of Terminal Charges to be collected by Port Trust Railways from customers.

Ref: Rates Circular No.4 of 2013 and 88 of 2007 {circulated vide CCM/ECOR's Circular No.33(G)/2013 dated 25.03.2013 & 187(G)/2007 dt.10.09.2007 respectively}.

- 1.0 In terms of Rates Circular No.4 of 2013, the rates for Terminal Charges to be collected by different Port Trust Railways for the period from 01.04.2013 to 31.03.2015 was conveyed to Zonal Railways.
- 2.0 The matter has been examined and it has been decided to revise the rates of Terminal Charges to be collected by Port Trust Railways of Mumbai, Kolkata, Chennai, Cochin, Paradip, Mormugao and Visakhapatnam (for Visakhapatnam in respect of traffic passing through north holding yard only), for the period 01.04.2015 to 31.03.2017 as Rs.22.97 per tone for all type of traffic.
- 3.0 In respect of Visakhapatnam Port Trust (Ore Exchange Yard), Terminal Charge rate will be Rs.80% of the rates indicated above.
- 4.0 The terms and conditions notified vide Rates Circular No.88 of 2007 in respect of collection and payment of Terminal Charges will continue to apply unchanged.
- 5.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.
