Sub: Wagon Registration Fee (WRF).

Ref: Board's letter No.99/TC-I/101/2 dated 20.01.2006 (Rates Circular No.7 of 2006) circulated vide CCM/ECOR's Commercial Circular No.13(G)/2006 dated 27.01.2006.

The instructions regarding lump sum deposit in lieu of Wagon Registration Fee, was notified vide Para 4.0 of Rates Circular No.7 of 2006. The matter has been reviewed and following has been decided:

- To revise the amount of lump sum deposit for Government Department from Rs.10,000/- to Rs.30,000/- with effect from **01.04.2015**.
- For PSU/Companies, the extant guidelines for fixing the lump sum amount by the Zonal Railway as prescribed for regular customers will continue to be applicable.

Accordingly, Rule 201(5) and 201(20) of Chapter II of Goods Tariff No.41 Pt.I (Vol.I) may be modified.

This issues with the concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.
