Sub: Change in ownership of 62 privately owned BTCS wagons.

- 1) Consequent upon the approval of the scheme of amalgamation and arrangements by an order dated 03.04.2013 of Hon'ble High Court of Bombay at Goa and by an order dated 25.07.2013 of Hon'ble High Court Madras, Aluminium business of **M/s Vedanta Aluminium Ltd** have been demerged and have become part of **M/s Sesa Goa Ltd**.
- 2) Further, by a fresh certificate of incorporation issued on 18th Sept'2013 by Registrar of Companies, Goa, Daman and Diu, the name of **M/s Sesa Goa Ltd** was changed to **M/s Sesa Sterlite Ltd** on and from 18th day of Sept 2013.
- 3) In view of the above, 62 number of privately owned BTCS wagons inducted by M/s Vedanta Aluminium Ltd as notified vide this office commercial circulars under reference (1) shall remain under the revised name of M/s Sesa Sterlite Limited.
- 4) Further, name of the siding appearing as "M/s VAL's Private Siding at Ambodala" or "Ambodala(MVAA)" in Commercial Circular under reference (2) to be read as "Private siding of M/s Sesa Sterlite Limited/Ambodala(MVAA)"
- 5) All other terms and conditions as was applicable to M/s Vedanta Aluminium Ltd shall apply also to M/s Sesa Sterlite Ltd.
