Sub: Adjustments in Base Freight Rates effective from 01.04.2015.

Ref: Board letter No.TCR/1078/2015/07 dated 16.03.2015 and 20.03.2015 (Rates Circular No.08 of 2015 and Corrigendum thereto) circulated vide CCM/ECOR's Commercial Circular No.30(G)/2015 dated 19.03.2015 and 31(G)/2015 dated 23.03.2015 respectively.

Please refer Board's letter cited above notifying adjustment in Base Freight Rates with effect from 01.04.2015.

Matter has been reviewed and it has been decided that following entries may be inserted in Goods Tariff No.48 Part.I (Vol.II).

- i) "Hydrogenated oils" in commodity Group No.11(a) with Class 140.
- ii) "Mustard Oil" (in covered wagons) and "All refined and Non-refined oil (in covered wagons)" in commodity Group No.11(b) with Class LR3.

All other details of Rates Circular under reference will remain unchanged.
