Sub: Adjustments in Base Freight Rates effective from 01.04.2015.

Ref: Board letter No.TCR/1078/2015/07 dated 16.03.2015 and 20.03.2015 (Rates Circular No.08 of 2015 and Corrigendum thereto) circulated vide CCM/ECOR's Commercial Circular No.30(G)/2015 dated 19.03.2015 and 31(G)/2015 dated 23.03.2015 respectively.

Please refer Board's letter cited above notifying adjustment in Base Freight Rates with effect from 01.04.2015.

Matter has been reviewed and it has been decided that the words "in **NMG/BCCN wagon**" in entry 25(m) "Motor Cars (in NMG/BCCN wagon)". Goods Tariff No.48 Part.I (Vol.II) stands **deleted** and the entry 25(m) shall be read as under:

MOTOR VEHICLES
MOTOR CYCLES
MOTOR TRACTOR NOC
MOTOR CARS

Note: *The Standardized" CC of NMG/BCCN wagons shall be 58.8 Tonnes

All other details of Rates Circular under reference will remain unchanged.
