## **Commercial Circular No.53 (G)/2015**

**Sub: Haulage Charge for movement of containers in privately owned wagons.**

Please refer to Board's letter under reference regarding Haulage Charge recoverable for movement of containers in privately owned wagons.

The matter has been examined and it has been decided to revise the following slabs of loaded container single deck as under::

<b>Existing Slabs</b>	<b>New Slabs</b>
'more than 26T and upto 30T'	'more than 26T and upto 31T'
'more than 30T'	'more than 31T'

The rates notified for the above tow existing slabs in the Rates Circular under reference will be applicable to the new slabs, respectively. Accordingly, in the Appendix-II of the circular, the slabs 'more than 26T and upto 30T' and 'more than 30T' may be read as 'more than 26T' and upto 31T' and 'more than 31T', respectively.


All other instructions of the circular under reference will remain unchanged.

These instructions will be effective from 10<sup>th</sup> May,2015.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of the Ministry of Railways.


