Sub:Free time for loading/unloading of Flat rake in the case of Freight terminals/sidings/goods sheds/steel plants on Engine-on-load.

Ref: Board's letter No.TC-I/2005/201/2 dated 30.08.2012 (Rates Circular No.23 of 2012) circulated vide CCM/ECOR's Commercial Circular No.87(G)/2012 dated 03.09.2012.

A clarification has been sought by Zonal Railways regarding permissible free time for loading/unloading of Flat rake in the case of freight terminals/sidings/goods sheds on Engine-on-load.

The matter has been examined and it has been decided to stipulate the permissible free time for loading/unloading of Flat rake in the case of freight terminals/ sidings/goods sheds/steel plants on Engine-on-load, as under:

Type of rake	EOL free time (in hours:minutes)	
	Loading	Unloading
Flat rake (BRN,BFN,CONCORD etc.	6.00	6.00

Accordingly, Para 2.5 of Rates Circular No.74 of 2005 stands modified.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
