Sub: Policy on Private Freight Terminal (PFT) Scheme.



(Amendment No.2 to Freight Marketing/Master Circular/PFT/2015/0)

- 1.0 Master Circular on 'Revised Private Freight Terminal' (PFT) Scheme was issued under 'Freight Marketing /Master Circular/PFT/2015/0' vide Board's letter No.2011/TC(FM)/14/14 dated 02.01.2015.
- 2.0 The policy on "Private Freight Terminal (PFT)" has been reviewed by Railway Board and it has been decided to make following amendment in the policy guidelines.
- 2.1 Para 20.0 of the aforesaid Circular regarding "Revenue Sharing" is hereby 'deleted' along with its sub-paras 20.1 to 20.5.
- 3.0 The above changes in the policy will come into force from 05.06.2015 without any retrospective benefit.
- 4.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.


