Sub: Running of freight trains on CC+8 routes.

Ref: Rates Master Circular/PCC/2014/0 dated 09.07.2014 and its Corrigendum dated 03.03.2015 & 12.03.2015 {CCM/ECOR's Circular No.81(G)/2014 dated 11.07.2014, 21(G)/2015 dated 04.03.2015 & 27(G)/2015 dated 13.03.2015 respectively}.

- 1.0 Please refer to Annexure III to Rates Master Circular under reference wherein list of CC+8 routes is prescribed. Now, sanction of the Central Government is hereby accorded to include following routes in the list of already identified CC+8 routes:

- 3.0 These instructions will come into effect from **01.06.2015** and will remain valid till further advice.
