The extract of Rly. Bd's letter under reference (ii) is reproduced below



Board desires that guidelines laid down in Para 3.1 in Board's above referred Rates Master circular are strictly complied with. Any deviation from the rules should be viewed seriously and deterrent action may be taken to prevent any such recurrence.

Please ensure that this is brought to the notice of Divisions immediately and to all other concerned."
