
Please refer to Board's letter No. 2009/TCFM/18/32 dt. 20.09.2011 vide which it has been decided that in the case of traffic originating / terminating from / to the M/s. DPCL siding in ECoR, RRs will be issued in the name of consignor / consignee instead of the port authority. This instruction was extended up to 31.12.2015 vide Board's letter of even number dt.11.03.2015 [CCM/ECoR's Commercial Circular No. 24(G)/2015 Dt. 12.03.2015]

The matter has been examined and it has been decided to extend the validity of the afore-mentioned instruction regarding issue of RR upto 30.06.2016.

This issues in consultation with Freight Marketing Branch of Commercial Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
