Sub: Levy of Surcharge on Goods and Passenger Traffic on Digha Railway Bridge on East Central Railway.

- 1.0 The guidelines regarding Levy of Surcharge on Goods and Passenger Traffic on Digha Railway Bridge on East Central Railway notified vide Rates Circular under reference.
- 2.0 The revised class of passenger traffic passing through Digha Railway Bridge are as under:

Surcharge on Passenger Traffic	
Class	Surcharge per passenger
1 st AC and 2 nd AC	Rs.25
3 rd AC, Chair Car and Sleeper	Rs.15
2 nd Class (Ordinary & Mail Exp)	Rs.5

- 3.0 All other details of Rates Circular under reference will remain same.


