Sub: Restriction on parcel & Goods traffic on Haridwar-Rishikesh-Dehradun Section in view of Ardh Kumbh Mela -2016.

Ref: Dy.CCM/FM-I/Northern Railway letter No.79/-RD/Ardh-Kumbh-Mela-Haridwar.2015 dated 31.12.2015 (This office Commercial circular No-02(GC) Parcel /2016 circulated vide letter No. CCM/432/Parcel & Luggage/09 dated 13.01.2016)

Please connect this office letter of even no. dated 13.01.2016 (Commercial Circular No.02 (GC) Parcel/2016 dated 13.01.2016) vide which restriction on Parcel and Goods traffic over JWP-DDN-RWL-RKSH section was imposed from 04.04.16 to 18.04.2016 due to Ardh Kumbh Mela.

The position has now been reviewed in view of security concern expressed by agencies and it has been decided to restrict movement of all type of Parcel and Goods traffic on Haridwar-Rishikesh-Dehradun section with immediate effect and upto 30.4.2016. Newspapers/Magazines & personal luggage would be exempted.
