Sub: Loading of import cargo arriving into ICD by Indian Railway general service wagons from the rail terminals of Container Train Operators.

In continuation to Railway Board letters under reference above and in modification of Para (6) of letter under reference (4), Railway Board has decided to permit outward booking of Import cargo after destuffing from containers customs cleared at CTO's ICD's, in IR general service wagons, provided the following conditions are strictly complied with:

- 1) Indent can be placed by 3rd party (Consignor/Consignee) of the cargo for onward movement in IR wagons.
- 2) CTO which owns the terminal shall ensure that goods which are not custom cleared in the same ICD, are not loaded in these wagons. CTO shall give a written undertaking that goods being loaded in general service wagons are custom cleared in the concerned ICD and not brought from any area outside the ICD.
- 3) All other instructions issued vide letter under ref (4) will continue to be followed.
