#### **Sub: Adjustment in Base Freight Rates – Classification of Commodities.**

Ref: Board letter No.TCR/1078/2015/07 dated 16.03.2015 and 20.03.2015 (Rates Circular No.08 of 2015 and Corrigendum thereto) circulated vide CCM/ECOR's Commercial Circular No.30(G)/2015 dated 19.03.2015 and 31(G)/2015 dated 23.03.2015 respectively.

- 1.0 Please refer Board's letter under reference notifying adjustment in Base Freight Rates with effect from 01.04.2015.
- 2.1 Sanction of the competent authority is hereby accorded to revise the classification of "Red Mud" appearing under the Main Commodity Head- Clay and Sand from Class – 150 to Class – 120.
- 2.2 Accordingly, the entry "Red Mud" may be deleted from Group 7 (a) and be placed in Group No.7 (b) under the Main Commodity Head – Clay and Sand at Page No.11 in the Goods Tariff No.48 Part.I (Vol.II).
- 3.0 All other details of the Rates Circular under reference will continue to apply unchanged.
- 4.0 These instructions shall come into effect from 06.06.2016 and shall remain in force till 31.03.2017.
- 5.0 This issues with the concurrence of the Finance Directorate of Ministry of Railways.
