Sub: - Traffic for the private siding of M/s. Jindal Steel and Power Limited served by Kerejanga station.

1. The private siding of M/s. Jindal Steel and Power Limited (Alpha Code: JSPK & Numeric code: 12221474) served by Kerejanga station over Sambalpur Division was notified for movement of the following inward and outward commodities:

Inward– Iron ore Fines, Iron ore lumps, Sponge Iron, Imported Coking Coal, Non-Coking Coal, Non- Coking Coal for coal washery, Dolomite & Dolomite fines, Lime Stone & Lime Stone fines, Quartzite, Misc. Flux & Ferro Alloy, Cement , MS Slab , Iron Pellets, Pig iron and Hot Briquetted Iron.

Outward–Steel, Slag, Lime Stone fines, Sponge Iron/DRI, Coal fines, Iron ore Pellets and Iron ore Fines.

2. Now, with the approval of competent authority, it has been decided to permit **Coal Tar & Gasification oil** as outward commodity from the siding.
3. With this inclusion, the revised list of permitted commodities for the siding is as under:

**Inward– Iron ore Fines, Iron ore lumps, Sponge Iron, Imported Coking Coal, Non-Coking Coal, Non- Coking Coal for coal washery, Dolomite & Dolomite fines, Lime Stone & Lime Stone fines, Quartzite, Misc. Flux & Ferro Alloy, Cement , MS Slab , Iron Pellets, Pig iron and Hot Briquetted Iron.**

**Outward–Steel, Slag, Lime Stone fines, Sponge Iron/DRI, Coal fines, Iron ore Pellets, Iron ore Fines, Coal Tar & Gasification oil.**
