**Sub:** Revision of permissible free time for loading/unloading at Greenfield PFT of Container Corporation of India Ltd (CCJS)

**Ref:** CCM/ECOR's Commercial Circular No.20(G)/2017 dtd.09.02.2017 and No. 59(G)/2017 dt.06.04.2017..

Greenfield Private Freight Terminal (PFT) of Container Corporation of India Limited (CONCOR) (Alpha Code- CCJS & Numerical Code--12328734) served by Jaggayapalem station over WAT division was notified open on through distance charging basis vide this office Commercial Circulars under reference, EOL free time for loading/unloading operation has been in force at the said PFT.

With the approval of competent authority, it has been decided that free times for loading /unloading of wagons as notified at Para No.2.2 of Railway Board's Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 dtd.19.05.2016 {CCM/ECOR's Commercial Circular No.65(G)/2016 dtd.20.05.2016} as applicable at Goods sheds shall be applicable at PFT of CONCOR {CCJS} with prospective effect i.e, from 10.01.2018.

All other terms and conditions of Commercial Circulars under reference will remain unchanged. Traffic of the Terminal Management Company (TMC) and the authorized rail-users of the PFT will be governed by PFT policy issued from time to time.
