**Sub: Guidelines regarding provision, installation and functioning of weighbridges.**

Ref: Rates Master Circular/Weighbridge/2014/0 and its corrigenda, circulated vide CCM/ECOR's Commercial Circular No.69(G)/2014 dated 12.06.2014.

Please refer to Para 2.7 of Rates Master Circular under reference on the above mentioned subject.

The matter has been reviewed and it has been decided to revise Para 2.7 of the above mentioned Rates Master Circular, as under:

"2.7 Functioning of all weighbridges in the Division should be reported in the daily position. If a weighbridge gets out of order, DRM shall have full powers to permit loading. GM shall be apprised of the weighbridge failure, in case weighbridge remains out of order for a continuous period of three months".

These instructions will be effective from **11.01.2018**.

This issue in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.

All concerned to note and act accordingly.
