Para 1 of the Freight Marketing Circular No. 01 of 2018 issued vide Board's letter No. 2017/TC(FM)/10/28 dated 11.01.2018 may be read as follows:

1. It has been decided to amend (i) para 14.1 of the "Modified Comprehensive Parcel Leasing Policy (CPLP)" issued vide FM Circular No. 06 of 2014; and (ii) para 6.0 of the Policy for leasing of Parcel Cargo Express Train (PCET) issued vide FM Circular 02 of 2007 as under:

Tender Committee for dealing with parcel leasing tenders i.e. CPLP and PCET would be constituted as per the 'Schedule of Powers (SOP)' given below-
