Sub: Charging of Kota stone in Containers

Ref: 1. Rates Master Circular/CRT-CCR-Hub&Spoke/2015/0 and its corrigendum No.9
(this office Commercial circular No.48 (G)/2015 dt 09.04.15 and its corrigenda)

Please refer to Corrigendum No.9 to Rates Master Circular/CRT-CCR-Hub&Spoke/2015/0
(this office Commercial circular No.47 (G)/2017 dt 30.03.17) vide which exemption of "Kota
stone" from the list of notified commodities has been extended upto 31.03.2018.

The matter has been reviewed and it has been decided to extend the validity of aforesaid
exemption of "Kota stone" from the list of notified commodities for a further period of one year
i.e upto 31.03.2019. "Kota stone" will continue to be charged at "Haulage charges per TEU"
basis instead of 'Container Class Rate' till such period.

Divisions will furnish monthly feedback regarding transportation of "Kota stone" in containers
for review.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of
Finance Dte. of the Ministry of Railways.
