Sub: Movement of Restricted Commodities (Quick lime) in Containers

Ref: 1. Railway Board's letter No.2008/TT-III/73/8 dt 01.07.08 (this office Commercial Circular No.82 (G)/2008 dt 15.07.08)

2. Railway Board's letter No.2011/TT-III/73/9 dt 22.02.17 (this office Commercial Circular No.27 (G)/2017 dt 03.03.17)

Attention is invited to Railway Board's letter under reference(2), permitting movement of Quick Lime in Container trains for a period of one year, which is valid till 28.02.2018.

It has now been decided that loading of Quick Lime in Container trains may be permitted wef 01.03.2018 to till further advice at FAK rates on experimental basis. Zonal Railways shall closely watch the movement of Lime/Quick Lime from their Railways to ascertain incremental quantity and earning from movement of Quick Lime.

FOIS/CRIS may capture the loading of Quick lime in containers under separate code issued by Railway Board vide Letter No. 2013/Stat. V/83/2/code dated 14.02.2017 for analysis in the future.

This issues with the approval of Traffic Commercial and Finance Directorate of Railway Board.
