(Amendment No.2 to Wagon Leasing Scheme)

Sub: Wagon Leasing Scheme (WLS).

Ref: Railway Board's Freight Marketing Circular No.08 of 2008 issued vide letter No.2008/TC(FM)/04/06 (WLS) dated 15.04.2008 {CCM/ECOR's Commercial Circular No.49(G)/08 dtd.25.04.2008}

- 1.0 In reference to FM Circular No.8 of 2008 issued vide Railway Board's letter under reference following amendment may be noted:
- 2.0 Para 7.3 may be read as follows:
"7.3 Procurement of wagons would be in units of the prescribed composition of block rakes for such wagons plus 4% wagons as maintenance spare along with a brake van for each rake. However, in case of wagons to be inducted under any specific Scheme by WLC, procurement of wagons as maintenance spare shall be governed as per the guidelines of that Scheme, prevailing at the time of approval."
- 3.0 This issues with approval of Traffic Transportation Directorate and Mechanical Directorate of Ministry of Railways.
- 4.0 This issues with the Finance Concurrence of Finance Directorate of Ministry of Railways..
- 5.0 This instructions will come into force from 07.03.2018.

All concerned to note and act accordingly.
