**Sub: Electronic Transmission of Railway Receipt(eT-RR)
Ref.: Rates Circular No.2 of 2015**

Please refer to Rates Circular No.2 of 2015 regarding guidelines for Electronic Transmission of Railway Receipt(eT-RR).

In terms of Para 10.0 of Rates Circular under reference, eT-RR has been implemented as a pilot project for POL traffic originating from HPCL terminal at Loni on Central Railway with effect from 30th January 2015.

eT-RR is now to be proliferated on pan India basis. In this regard, a meeting was held in Railway Board with FOIS and CRIS, who informed that modalities of eT-RR have been made fully operational in the system and the same is ready for proliferation.

The matter has been reviewed and following have been decided:

- **The system of eT-RR will be implemented over Northern Railway in second phase.** For this purpose, FOIS will prepare detailed implementation plan and monitor its implementation on day-to-day basis. Feedback may be furnished by FOIS and NR(with concurrence of associate Finance) after a month.
- NR shall take immediate steps to expedite registration of its customers(consignors and consignees); and shall ensure completion of all pre-requisites for eT-RR. NR shall track issuance of eT-RRs and take necessary action through FOIS to resolve issues that may arise.
- Other Zonal Railways may also take immediate steps for registration of their customers under e-RD module of FOIS so that eT-RR may be proliferated on pan India basis in the next phase. Railways may coordinate with FOIS for obtaining User ID and Password for their goods sheds staff. FOIS will organize requisite training programmes for concerned railway officials to facilitate smooth implementation of eT-RR.
- Special attention may be paid to ensure sanctity of field users'/Goods Clerks' IDs & password on TMS through training as well as system checks.

This issues with the concurrence of Finance Dte. of Railway Board(Ministry of Railways).
